2025-2026 League Operator Checklist

*All WAMO Pool Leagues must be run on CompuSport, No Exceptions! *

Pool Sanctioning Information:

 Players that play a minimum of 3 weeks in a WAMO Sanctioned League must be sanctioned through CompuSport and are required to pay the \$5 Per Player Sanction Fee.

Sanction Fee Price Per Player will increase to \$6 per player in 2026-27 Season

- WAMO Pool League Qualifications:
 - A League must consist of 3 locations and 6 teams.
 - Teams must consist of two or more players.
 - All teams in a League must play on tables owned and operated by a WAMO Charter Member. In leagues with more than one WAMO Charter Member, one of the Charter holders must sponsor the league.
 - o 9 weeks of league play are needed to qualify. The qualifying weeks are from August 15, 2025, to February 11th, 2026.
 - All players must come from within the same league operator system.
 - o In-House leagues do not qualify for the WAMO Pool Tournament
 - Stats do not need to be sent in but they do need to be entered into CompuSport on a weekly basis so that CompuSport rankings are accurate and so the Director can see that players are being accounted for.
 - Location Reports & League Summary Report are mandatory and need to be sent in with your sanction payment by January 30, 2026, to



How to Sanction Players in CompuSport:


- Log into your 2025-2026 Pool League Account
- In the 2nd column under the "Players | Teams", locate the "Player Sanctions" feature
- Once in this feature you can select WAMO for
 "Association" and then select each "Division" that is
 sanctioned for WAMO Pool. You can select multiple divisions at once or you
 can do them individually.



- Your list of players will then populate for that league/division
- Filter your viewable fields to see what is necessary for sanctioning
 - o For example, this works well
- Next, check each individual player that has played more than 3 weeks of league play by:
 - Clicking the box across from their name and then hitting the blue save button in the top left corner of that screen.
 - Once that is clicked a blue check mark will appear indicating that they're sanctioned for WAMO, what date/time they were sanctioned and what team they were sanctioned with.



 Once you have checked all the players that should be sanctioned, they will then show in your CompuSport WAMO Pool Portal. The CompuSport WAMO Pool Portal allows you to view your Players and Sanctions and eventually register for the WAMO Pool Tournament.

Pool Tournament Information:

- The 2026 WAMO State Pool Tournament will be held at the Resch Expo Center in Green Bay, WI from March 11-15, 2026.
- All 2026 Tournament Entries must be submitted in 2 steps
 - 1. Each WAMO Operator must have their player's entries in the WAMO Pool CompuSport Portal by February 2, 2026.
 - Website: www.compusport.us/wamo
 - 2. All paper entries and monies are to be made out to and sent to the Tournament Director no later than February 2, 2026.

Pool Tournament Fine Details:

- The deadline for players to get their entries to you the League Operator is
 January 30, 2026. It is the Operator's responsibility to ensure that all entries
 are entered correctly into CompuSport and that all requirements are met.
 - Late entries may be accepted under the Tournament Director's discretion. It will be a \$25 late fee for singles & \$50 for team.
- Players must be 21 years or older to be allowed into the Tournament.
- The CSR or CompuSport Rank System will determine which division players will be in for singles and team events.
- Roster changes can be made at the tournament for \$40 (cash only)
 adjustment. This adjustment to your roster must be MADE 24 HOURS before
 the start of your event. Money directly impacts the WAMO Scholarship Fund.
- Work shift options will be sent once Tournament Entries are finalized

Pool Tournament Events:

- Senior Singles (50 + years of age on or before January 30, 2026)
- 9 Ball Singles
- Women's Singles
- Open Singles (Open to male or female players)
- Open Scotch Doubles (Pre-registered event in 2026)
- Open Team Event (5 player teams, all need to be from the same league system)
- Women's Team Event (4 player teams, all need to be from the same league system)

All pool tables used in a league must be owned and operated by a WAMO member(s) that has a current pool charter. One of those operators must sponsor that league. A sponsor is responsible for collecting and sending in all location reports for every operator who has teams in their league(s). A copy of the league schedule(s) for every sanctioned league(s) that you have locations playing in must be sent in this report. There must be location reports matching all the teams listed on a schedule or sanctioning will be denied. If you own and operate all the pool tables in a league you may send in a copy of that league schedule and list the league on one of the location lines below. Schedules must be saved for 2 years. LEAGUE DEFINITION: NO LESS THAN 6 TEAMS (2 or more players), PLAYING IN NO LESS THAN 3 LOCATIONS, FOR NO LESS THAN 10 WEEKS. IN HOUSE LEAGUES AND 1 PLAYER TEAMS DO NOT QUALIFY!
