- **CRICKET DOUBLES - WEDNESDAY MAY 13th; 1:00PM START TIME**
- **SINGLES - THURSDAY MAY 14th; 2 SHIFTS: 9:00AM (LOWER PPDs) AND 4:00PM (HIGHER PPDs)**
- **DOUBLES - FRIDAY MAY 15th; 2 SHIFTS: 9:00AM (LOWER PPDs) AND 4:00PM (HIGHER PPDs)**
- **TEAM ROUND ROBINS - SATURDAY MAY 16th; 2 SHIFTS: 9:00AM (LOWER PPDs) AND 4:00PM (HIGHER PPDs)**
- **TEAM FINALS WILL ALL START SUNDAY MAY 17th 9:00AM.**

TOURNAMENT ENTRY: TEAMS MAY ENTER WITH ANY 4 TO 6 PLAYERS FROM THEIR LEAGUE SYSTEM. A LEAGUE SYSTEM IS DEFINED AS PLAYING FOR ONE LEAGUE OPERATOR THAT MANAGES THE LEAGUE. YES, PLAYERS FROM DIFFERENT TEAMS MAY COMBINE FOR STATE. WITH THE MANDATORY COMPUTER ENTRY, YOU ONLY NEED TO SEND IN 1 COPY OF THE PLAYER STANDINGS, FOR YOUR SANCTIONED LEAGUE(S).

PLEASE READ: The information below highlights league requirements for League Leader & sanctioning.

- SANCTIONING PAPERWORK IS AVAILABLE TO PRINT OR DOWNLOAD ON THE WAMO WEBSITE: WWW.WAMO.NET LOG IN, CLICK ON “MEMBERSHIP” AT THE TOP OF PAGE, SELECT “MANAGE MY ACCOUNT”, THEN SCROLL DOWN TO “POOL & DART TOURNAMENT DOCUMENTS”
- REMOTE LEAGUES
ALL REMOTE LEAGUES MUST BE APPROVED BEFORE YOU START
SEND REMOTE LEAGUE FORM ASAP TO BE APPROVED BY THE WAMO BOARD
- TEAM NAMES MUST MEET LEAGUE LEADER REQUIREMENTS. NO PUNCTUATION AND 20 CHARACTERS MAXIMUM THIS IS A TOURNAMENT REQUIREMENT!
- ALL TEAM PLAYERS MUST COME FROM THE SAME LEAGUE SYSTEM. “01” DOUBLE PLAYERS MUST ALL COME FROM THE SAME LEAGUE SYSTEM!

EVEN THOUGH SANCTIONING WON'T BE DONE UNTIL LATER IN THE SEASON WE STILL NEED THE SUMMARY REPORTS AND LOCATION REPORTS SENT IN AS SOON AS LEAGUES ARE ESTABLISHED

WAMO DART SANCTIONING GUIDELINES 2025-2026

LEAGUE:

ALL TEAMS, (2 OR MORE PLAYERS), IN A LEAGUE MUST PLAY ON MACHINES OWNED AND OPERATED BY A CHARTERED WAMO MEMBER. IN LEAGUES WITH MORE THAN ONE WAMO CHARTER MEMBER, ONE OF THE CHARTER HOLDERS MUST SPONSOR THE LEAGUE. SPONSOR IS RESPONSIBLE FOR COLLECTING ALL LOCATION REPORTING FORMS, SENDING IN LEAGUES STATS AND COMPUTERIZED TOURNAMENT ENTRY. THE LOCATION REPORTING FORM MUST BE TURNED IN 1 WEEK AFTER THE FIRST SANCTIONING DEADLINE: DECEMBER 1ST 2025. THE LOCATION REPORT FORM MUST BE COMPLETED AS INSTRUCTED ON THE FORM. ALL LEAGUES MUST USE AN AUTHORIZED COMPUTER PROGRAM FOR MAINTAINING THE PLAYER STATISTICS. REMOTE LEAGUES MUST APPLY FOR THEIR LEAGUE(S) TO BE SANCTIONED. IN HOUSE LEAGUES AND 1 PLAYER TEAMS DO NOT QUALIFY.

REPORTS:

A COMPUTER FILE (DMWAMO.TXT) IS TO BE SENT ON THE 1ST OF EVERY MONTH. THE WAMO FILE IN LEAGUE LEADER IS HOW TO SUBMIT THE LEAGUE REPORTS TO ME EACH MONTH AND ALSO USED AS YOUR IMPORT INTO COMPUSPORT FOR SANCTIONING. THIS IS FOUND UNDER THE MASTER SECTION, UNDER REPORTS. IT'S CALLED WAMO DARTS EXPORT. LEAGUES WHERE THE STATS/RECORDS ARE NOT KEPT BY THE SPONSORING OPERATOR, SAME RULES APPLY. ALL STATS/RECORDS ARE KEPT BY THE SPONSORING OPERATOR AND COME FROM AN ONLINE SYSTEM. ALL REPORTS MUST SHOW: FIRST, LAST, LEAGUE, TEAM, ADDRESS, CITY STATE, ZIP, PHONE AND EMAIL GAMES AND PPD FOR “01” LEAGUES OR MPR FOR CRICKET LEAGUES. A DIGITAL COPY OF FINAL LEAGUE STATS MUST BE SAVED FOR 2 YEARS.

COSTS:

SANCTION FEES ARE \$5.00 PER PLAYER (ONLY SANCTION PLAYERS WITH 24 GAMES OR MORE ON 12/01/2025) THE LOCATION REPORT AND LEAGUE SUMMARY WILL BE DUE 1 WEEK AFTER SANCTIONING. THERE IS NO LIMIT TO THE NUMBER OF PEOPLE YOU CAN SANCTION BUT SIXTY (60) GAMES IS THE MINIMUM REQUIRED NUMBER OF GAMES A PLAYER MUST PLAY IN A LEAGUE SYSTEM TO PLAY IN ANY OF THE STATE TOURNAMENT EVENTS, 24 GAMES OF CRICKET ARE NEEDED TO PLAY IN THE CRICKET EVENT.

PAYMENT:

PAYMENT CAN BE MADE IN 2 WAYS, USE A CREDIT CARD RIGHT ON THE COMPUSPORT WEB SITE (PREFERRED), OR MAIL CHECK TO WAMO DARTS WITH COPY OF INVOICE, 1161 INDUSTRIAL PKWY, FOND DU LAC, WI 54937. FIRST SANCTIONING PAYMENT AND DOWNLOAD DUE BY DECEMBER 1ST, 2025. FINAL SANCTIONING DOWNLOAD AND PAYMENT DUE MARCH 1ST, 2026.

TOURNAMENT:

ALL OPERATORS WHO HAVE ENTRIES WILL BE REQUIRED TO PROVIDE LABOR OR BUY DART MACHINES. ALL WORK SHIFTS AT STATE TOURNAMENT ARE AT LEAST 6 TO 8 HOUR SHIFTS. ONE WORK SHIFT PER EACH 4 PLAYER TEAM ENTERED. IF YOU DON'T HAVE ANY TEAMS BUT HAVE SINGLES OR DOUBLES ENTRIES, ONE SHIFT FOR EVERY 4 PLAYERS. ALL WORKERS MUST BE 21 YEARS OF AGE OR OLDER. WORK SHIFTS AND OR MACHINE PURCHASES WILL BE DECIDED BY THE NUMBER OF ENTRIES AN OPERATOR HAS ENTERED IN THE TOURNAMENT. WORK SHIFTS AND MACHINE NEEDS WILL BE DETERMINED BY APRIL 20TH AND OPERATORS WILL BE NOTIFIED OF THEIR REQUIREMENTS BY EMAIL. OPERATORS NOT COMPLYING WITH THE NEEDS OF THE TOURNAMENT WILL BE ASSESSED FINES OR SUSPENSIONS AS STATED IN YOUR CHARTER.

IF YOU HAVE NOT PAID YOU CHARTER FEE, PLEASE DO SO NOW TO AVOID LATE FEES. ALL NEW OPERATORS AND LEAGUE COORDINATORS SHOULD SEND AN EMAIL WITH A SUBJECT LINE OF "WAMO DART LEAGUE CONTACT EMAIL" TO AVOID MISSING ANY CORRESPONDENCE TO:

A SPONSOR IS RESPONSIBLE FOR COLLECTING AND SENDING IN ALL LOCATION REPORTS FOR EVERY OPERATOR WHO HAS TEAMS IN THEIR LEAGUE(S). A COPY OF THE LEAGUE SCHEDULE(S) FOR EVERY SANCTIONED LEAGUE(S) THAT YOU HAVE LOCATIONS PLAYING IN MUST BE SENT WITH THIS REPORT. THERE MUST BE LOCATION REPORTS MATCHING ALL THE TEAMS LISTED ON A SCHEDULE OR SANCTIONING WILL BE DENIED. SCHEDULES MUST BE SAVED FOR 2 YEARS.
